Rural Telehealth Certificate Program (RTCP): Nurse Practitioners working in all areas of healthcare and especially in rural health care will engage in telehealth. The RTCP is designed to educate the next generation of rural health advanced practice nurses in telehealth. The innovative RTCP prepares nurse practitioners to provide telehealth services in rural, medically underserved areas, and to serve as leaders in improving quality and access to care for these patients.

Clinical Hours: The required 90 clinical hours of telehealth can be applied to DNP program specialty clinical hour requirements. For example the FNP Specialty requires 720 clinical hours the 90 telehealth hours would be applied and the remaining required FNP clinical hours would be (720-90) = 630 FNP clinical hours.
